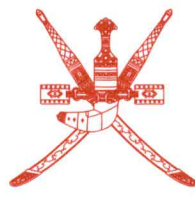

<p>Please note that we have received several non-compliance reports for incidents related to prescribing Narcotic/ Psychotropic medicines conducted by some health care professionals. We would like to stress on the importance of not Prescribing and dispensing controlled Narcotics/Psychotropics against prescriptions that lack the information /specifications stated by the Law of Combat of Narcotics and Psychotropic Substances issued by the Royal Decree No 17/99 and its amendments and the Executive Regulations issued by the Ministerial Resolution No. 98/2001.</p>	<p>نظراً لتعدد المخالفات المرصودة من قبل بعض مقدمي الرعاية الصحية ، و على ضوء التقارير الواردة للمديرية العامة للصيدلة و الرقابة الدوائية، فإننا نؤكد على ضرورة الإلتزام بما ورد في قانون مكافحة المخدرات والمؤثرات العقلية الصادر بالمرسوم السلطاني رقم 99/17 وتعديلاته و لائحته التنفيذية و جميع التعاميم الصادرة من هذه المديرية فيما يخص هذا الشأن. كذلك تؤكد المديرية على أهمية التقيد بشروط كتابة و صرف الوصفات الخاصة بهذه الأدوية و شروط التعامل معها داخل المؤسسات الصحية الحكومية و الخاصة كما هو منصوص عليه في دليل التعامل مع هذه الأدوية.</p>
