

Reason	The distance between the Connector Box's ethernet-port and internal electronic components is insufficient to provide adequate electrical insulation to the medical device in case of the presence of high voltages on ethernet installations. In its current state, the device does not conform to company requirements.
	1. Disconnect all connected devices from the ethernet network now. Please do not connect any devices without sufficient voltage protection.
Action	 A safety kit, consisting of a network isolator which is tested for compliance with the stipulations set out in EN 60601- 1:2006/A1:2013, a supplement to the Instructions for Use, as well as a warning label to be affixed to affected devices, will be provided to all users of affected devices. This safety kit will be dispatched to you by your distributor or by Haag-Streit directly. Contact the local agent for remedial action.
