Explanation

Abbott has identified that some positive control 2 vials of Alinity i HBsAg Control Kit, LN 08P0810 lot number 59044FZ00 and ARCHITECT HBsAg Control Kit, LN 6C36-10 lot numbers 60109FZ00 and 59039FZ00 may contain a fungal contaminant which could result in aspiration errors. We received complaints associated with this issue due to aspiration errors and/or material clogging the dispensing tip of the Positive Control 2 (PC2) vial, also with reports of visible material in the PC2 component only.

Abbott is investigating this event and will take the necessary actions to prevent recurrence in the future.
