Description of the problem and immediate action required

TRACOE medical GmbH is issuing a Field Safety Notice for the above products as the application bears a very low risk of tearing off the silicone sleeve when removing the insertion system. The incidence rate is 0.016 % and may be further minimized if the application is performed as described in the IFU.

Despite general measures in production and in-process control to improve the strength of adhesion of the silicone sleeve to the guiding catheter, a small residual risk remains during use, as in all areas of medicine.

To reduce these risks even further, please pay close **attention to the instructions in the user manual** and in particular to the following points:

Before Use:

- Keep a ready-to-use spare tube, several spare inner cannulas, and an identical twist plus or vario
 experc set of the same size at the patient's bedside as a replacement.
- Tubes with 1 2 sizes smaller diameter should be at hand for emergency use.
- Take appropriate safety measures that allow the user to carry out short-term ventilation using translaryngeal intubation or a laryngeal mask.
- Check the tube for integrity and correct function and make sure that the inserter / insertion system is correctly assembled.
- Do not disassemble the pre-assembled tracheostomy tube consisting of inserter / insertion system with guiding catheter and cannula.
- Do not pull on the tip of the guiding catheter or silicone sleeve.

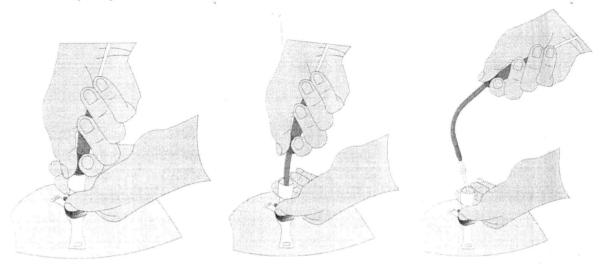
During use:

- Apply a pea-sized amount of the enclosed lubricating gel on the tip of the inserter / insertion system and the tracheostomy tube.
- Do not pull on the guiding catheter separately while the inserter is still inside the tube. Pull out the inserter / insertion system always together with the guiding catheter and Seldinger wire or remove the inserter first before pulling on the guiding catheter leaving the tracheostomy tube in place in the trachea.
- Ensure that the silicone sleeve is still on the guiding catheter when the guiding catheter is pulled out.

- If the silicone sleeve detaches from the guide catheter, proceed as follows:
 - Immediate inspection of the lumen of the tracheostomy tube. If the sleeve remains in the tube, the
 inner cannula must be removed immediately for TRACOE twist plus. In case of a single-lumen
 tracheostomy tube (TRACOE vario) it must be replaced with the spare device immediately.
 - If the silicone sleeve is not visually detectable in the lumen of the tube, we recommend taking a chest X-ray for the precise localization immediately. Since the silicone sleeve is radiopaque, the X-ray serves as preparation for bronchoscopic removal.
- Only for TRACOE twist plus: If the inserter is too difficult to be remove, it can also be removed together
 with the inner cannula. Therefore, loosen the inner cannula by turning the locking ring. If the inner cannula is
 removed when removing the inserter, it must be reinserted into the tracheostomy tube without the insertion
 system and locked into place by turning the locking ring.
