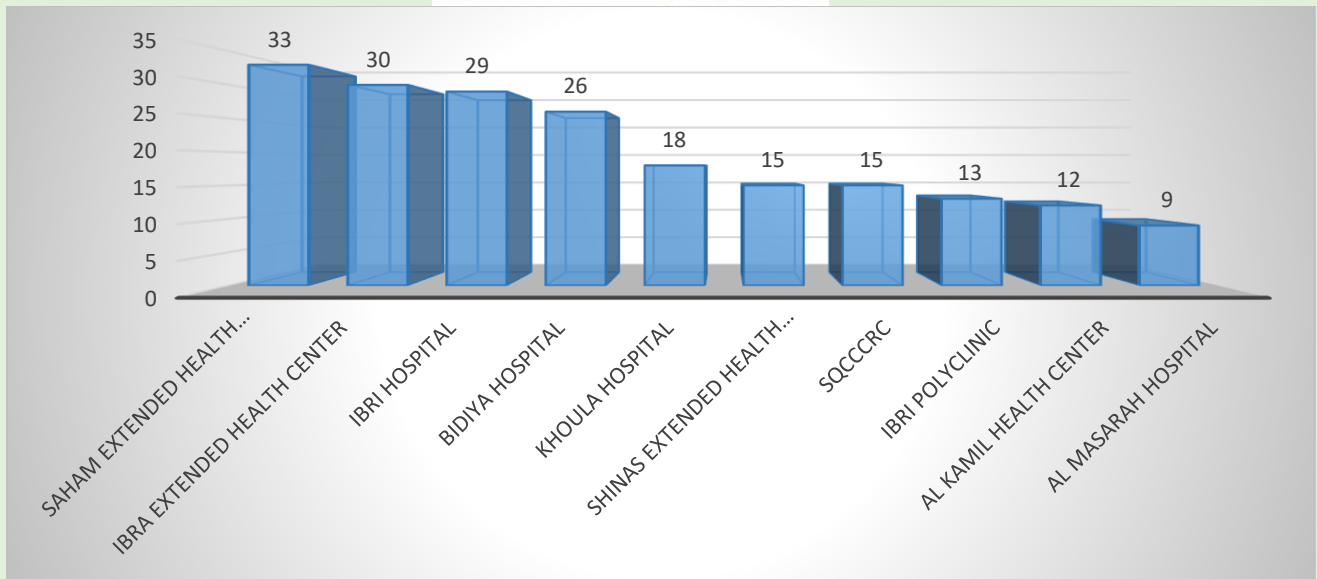


Figure 1: Top ten ADR Reporters in January 2023

The **Highest** number of QP reports received from **Qurayat Hospital** (7 reports).

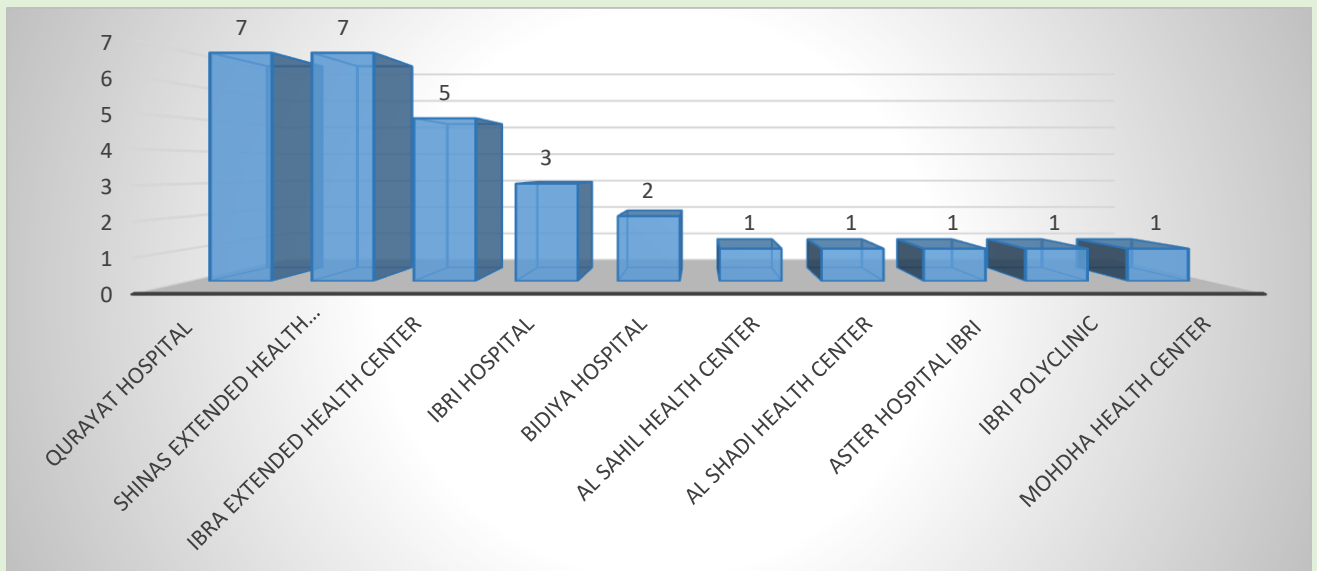


Figure 2: Top Ten Quality Problem Reporters in January 2023
