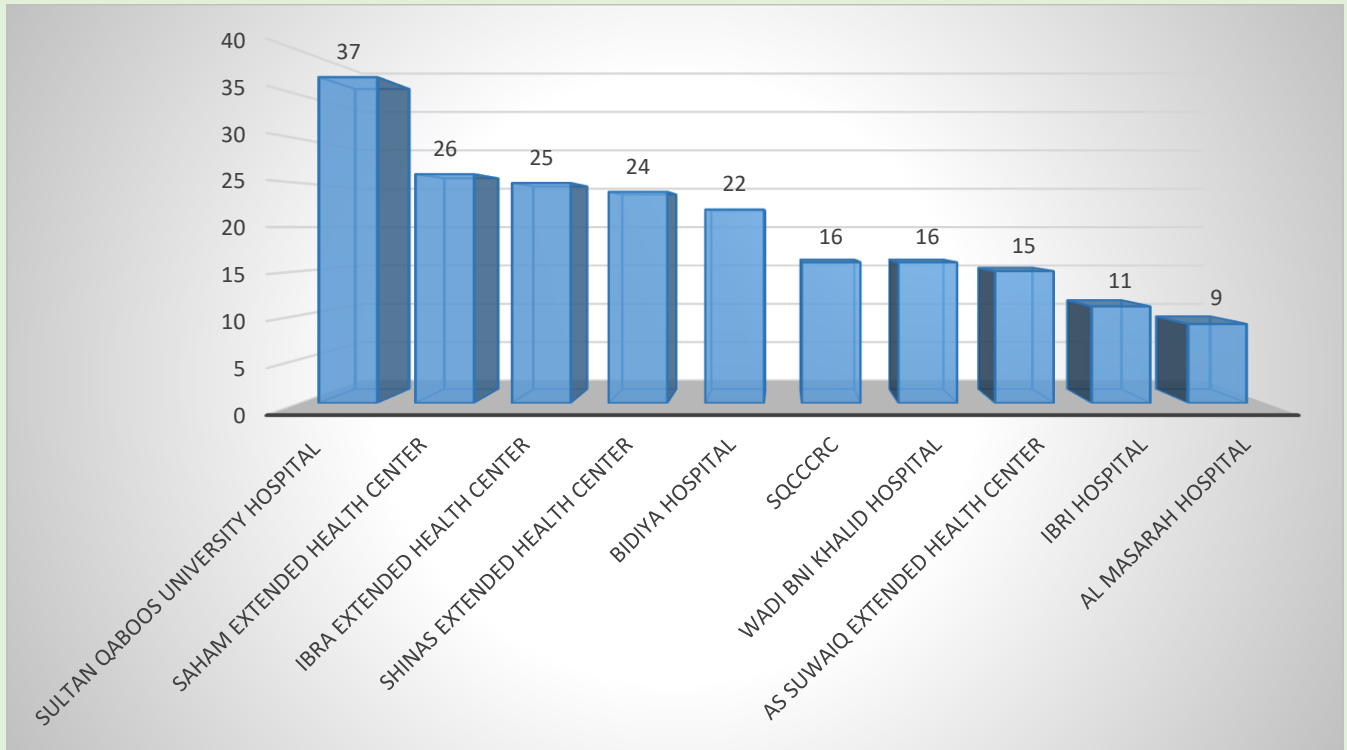


Figure 1: Top ten ADR Reporters in April 2023

The **Highest** number of QP reports received from **Shinas Extended Health Center** (19 reports).

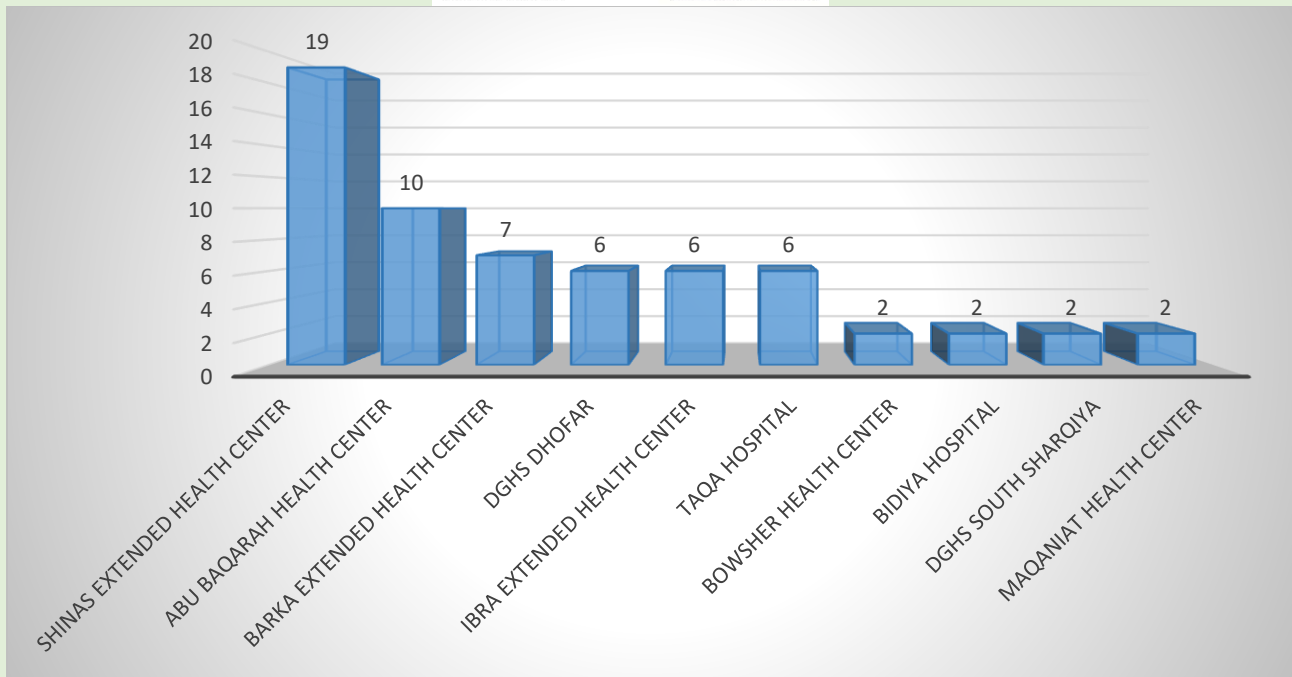


Figure 2: Top Ten Quality Problem Reporters in April 2023

The **Highest** number of reports received from **Bidiya Hospital** (03 reports).

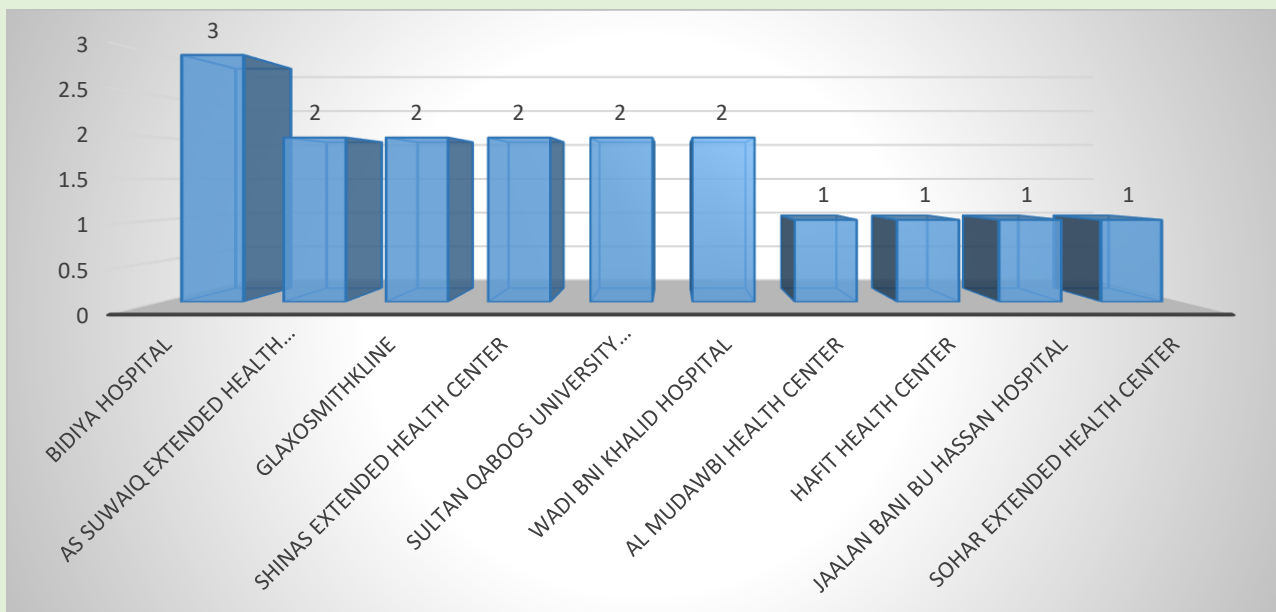


Figure 3: Top Ten Drug Ineffective Reporters in April 2023
