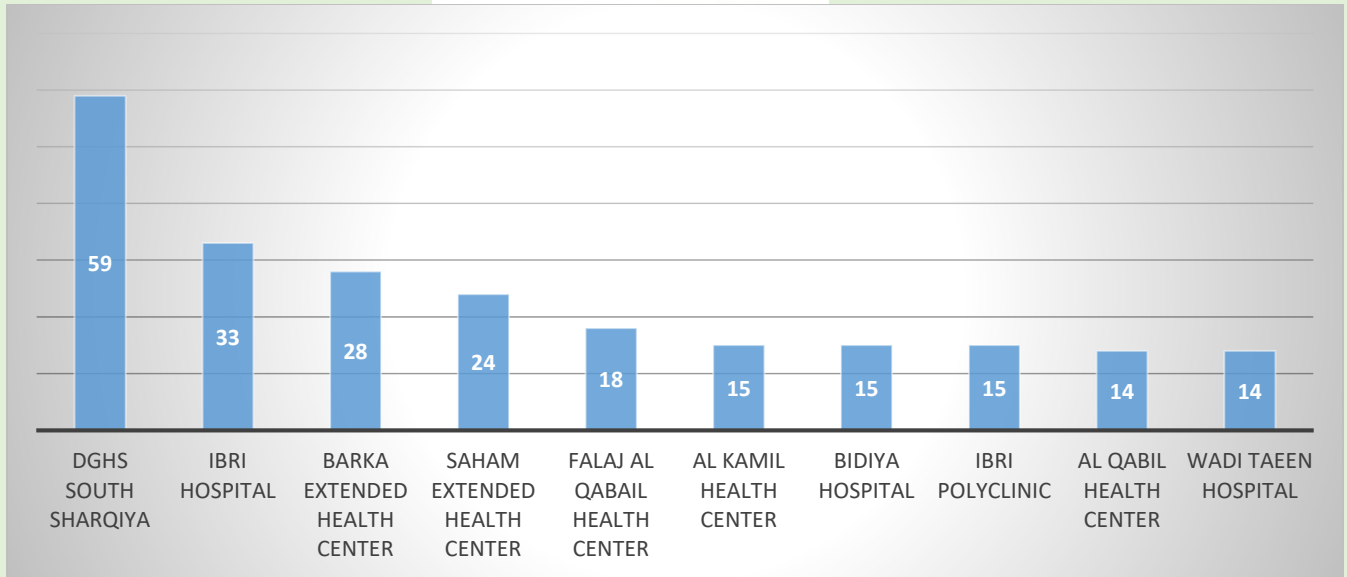


Figure 1: Top ten Reporters in December 2022

The **Highest** number of QP reports received from **DGHS South Sharqiya** (18 reports).

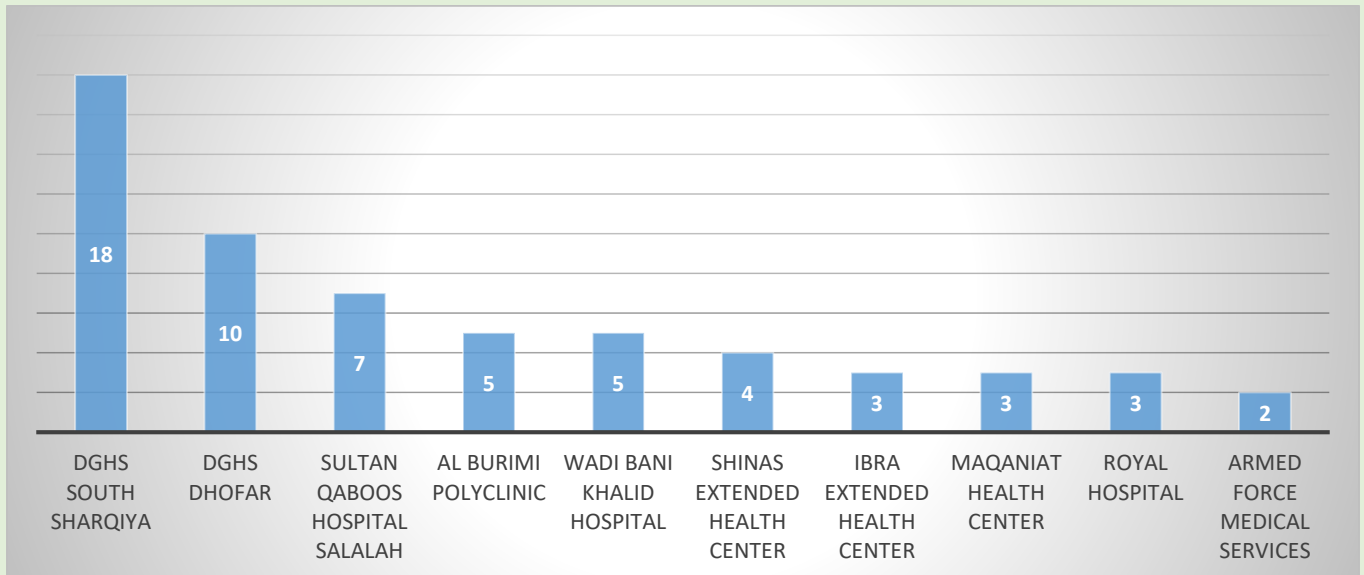


Figure 2: Top Ten Quality Problem Reporters in December 2022

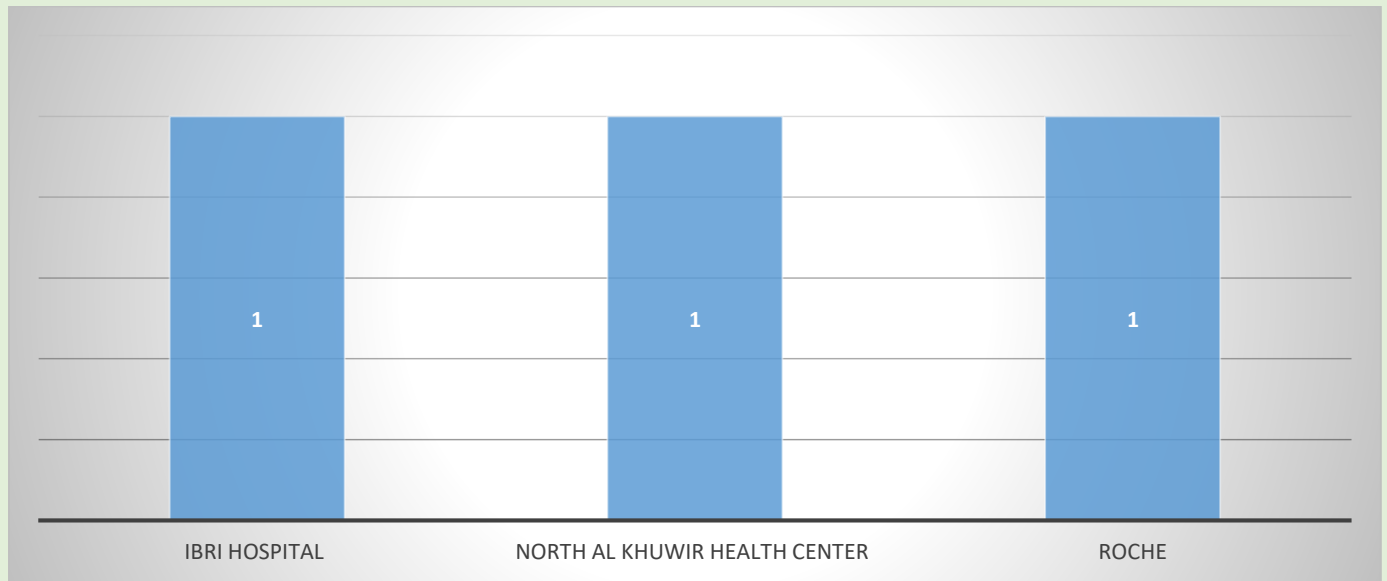


Figure 3: Medication error Reporters in December 2022

Total of (3) Quality Problem Reports received in December 2022 (**Figure 3**).
