#### **2.1 Adverse Drug Reaction (ADR) Reports:**

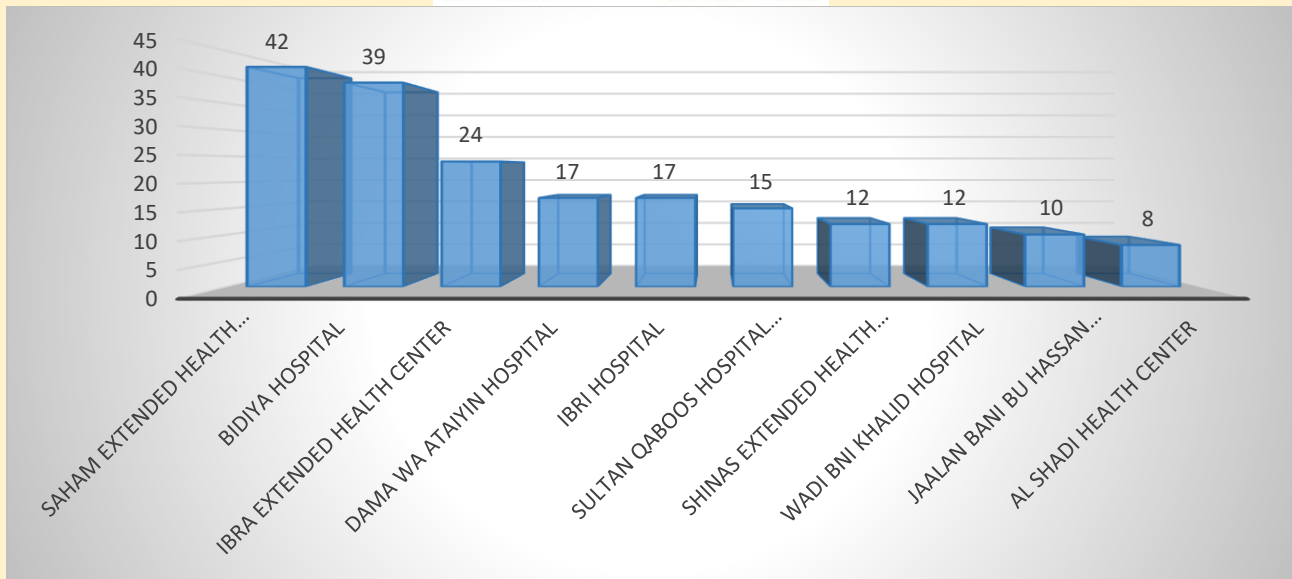
Total of **(283)** Adverse Drug Reaction Reports received in September 2022 from government and private health and pharmaceutical establishments (**Table 1**).

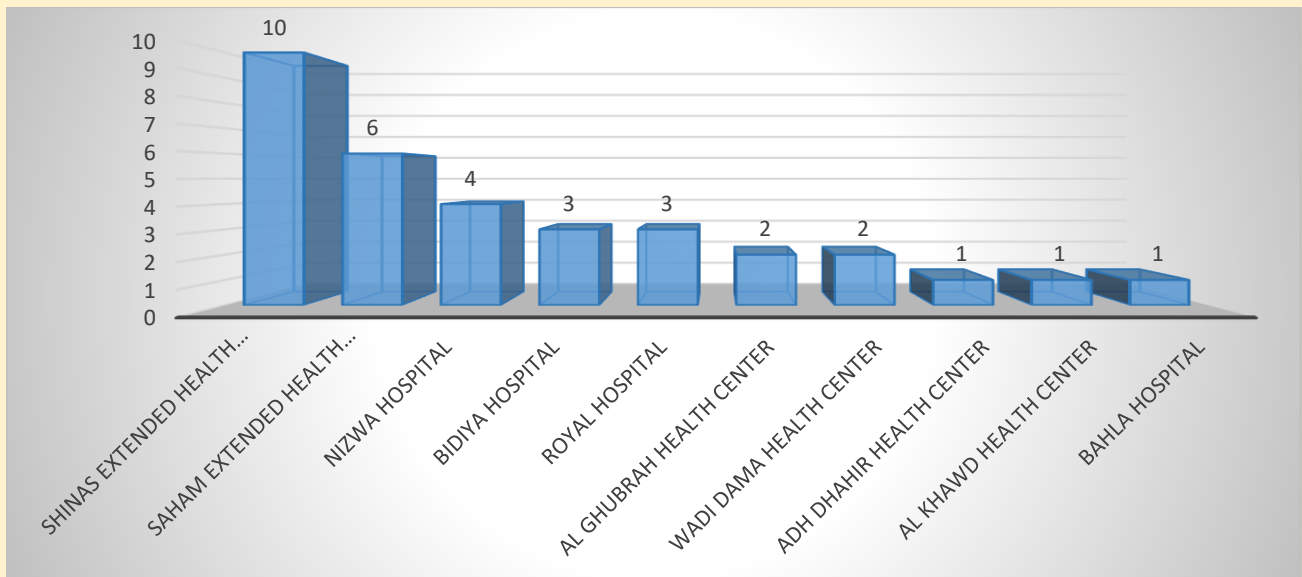


**Figure 1:** Top ten Reporters in September 2022
